PRC Supreme People Court's Forwarder Rules

The PRC's Supreme People Court has implemented two sets of Rules dealing with the matters and claim cases concerning forwarders. The set of 15 Rules has been effective since 5/3/2009, and the other set of 16 Rules has recently been effective since 1/5/2012. These two sets of Forwarder Rules are obviously very important to the forwarders which do businesses in the PRC since they greatly affect the risks, liability and survival of the forwarders.
